NOTE: FAILURE TO FOLLOW INSTALLATION INSTRUCTIONS AND NOT USING THE PROVIDED HARDWARE MAY DAMAGE THE INTAKE TUBE, THROTTLE BODY AND ENGINE.

#### TO START:

1. Turn off the ignition and disconnect the negative battery cable.

NOTE: Disconnecting the negative battery cable erases pre-programmed electronic memories. Write down all memory settings before disconnecting the negative battery cable. Some radios will require an anti-theft code to be entered after the battery is reconnected. The anti-theft code is typically supplied with your owner's manual. In the event your vehicles anti-theft code cannot be recovered, contact an authorized dealership to obtain your vehicles anti-theft code.





3. Depress the locking tab and disconnect the two vent lines from the air filter housing.



5. Remove the bolt that secures the fresh air duct to the fender. Remove the complete intake system

2. Disconnect the inlet air temperature sensor electrical connection and unhook the wiring harness from the intake tube.



4. Remove the two bolts that secure the intake tube to the core support. Loosen the hose clamp securing the intake tube to the throttle body.

NOTE: K&N Engineering, Inc., recommends that customers do not discard factory air intake.



6. Remove the six retaining clips that secure the grill assembly to the core support. Remove the grill assembly.

7. Remove the two bolts securing the diagonal core support brace and remove the brace. **NOTE: This brace will be reinstalled.** 



8. Remove the two bolts that secure the fresh air duct to the core support and then remove the duct from the vehicle.



9. Reinstall the core support diagonal brace using the factory hardware.



10. Reinstall the grill and secure with the factory retaining clips.



12. Install the O-ring onto the ejector fitting provided and then install the fitting into the K&N<sup>®</sup> intake tube. Secure the fitting with the clip and hardware provided.



13. Remove the inlet air temperature sensor from the factory intake tube. Remove the O-ring from the sensor and then install the sensor into the K&N<sup>®</sup> intake tube using the provided grommet.



14. Install the air filter onto the end of the K&N<sup>®</sup> intake tube and secure with the provided hose clamp.



15. Install the intake tube assembly into the  $K\&N^{\mbox{\tiny \$}}$ 



17. Install the intake assembly into the vehicle so the mounting studs insert into the mounting grommets and the intake tube inserts into the coupler. Secure the system with the provided hose clamp and hardware.



18. Connect the CCV lines to the ejection fitting installed into the intake tube.



19. Reconnect the vehicle's negative battery cable. Double check to make sure everything is tight and properly positioned before starting the vehicle.

20. The C.A.R.B. exemption sticker, (attached), must be visible under the hood so that an emissions inspector can see it when the vehicle is required to be tested for emissions. California requires testing every two years, other states may vary.

21. It will be necessary for all K&N<sup>®</sup> high flow intake systems to be checked periodically for realignment, clearance and tightening of all connections. Failure to follow the above instructions or proper maintenance may void warranty.

### **ROAD TESTING:**

1. Start the engine with the transmission in neutral or park, and the parking brake engaged. Listen for air leaks or odd noises. For air leaks secure hoses and connections. For odd noises, find cause and repair before proceeding. This kit will function identically to the factory system except for being louder and much more responsive.

2. Test drive the vehicle. Listen for odd noises or rattles and fix as necessary.



11. Install the provided mounting post onto the K&N<sup>®</sup> air filter housing using the provided hardware.

16. Install the provided step coupler onto the throttle body and secure with the provided hose clamp.

3. If road test is fine, you can now enjoy the added power and performance from your kit.

4. K&N Engineering, Inc., requires cleaning the intake system's air filter element every 100,000 miles. When used in dusty or off-road environments, our filters will require cleaning more often. We recommend that you visually inspect your filter once every 25,000 miles to determine if the screen is still visible. When the screen is no longer visible some place on the filter element, it is time to clean it. To clean and re-oil, purchase our filter Recharger<sup>®</sup> service kit, part number 99-5050 or 99-5000 and follow the easy instructions.
